

RESOLUTION NO. R26-30

A RESOLUTION BY THE TROTWOOD CITY COUNCIL ACCEPTING THE BID OF NEYRA CONSTRUCTION, INC. FOR PAVEMENT REPAIRS AND RESURFACING WORK TO BE COMPLETED ON THE FOLLOWING ROADWAYS: SEVEN GABLES AVENUE (FAIRGROVE WAY TO SYLVAN OAK DRIVE), SYLVAN OAK DRIVE (HORRELL ROAD TO DEAD END), CHAPLEN DRIVE (PATRICK STREET TO SKINNER DRIVE), BURMAN AVENUE (GLENSIDE COURT TO OLIVE ROAD), POST TOWN ROAD (NORTH UNION ROAD TO CITY CORP. LIMITS), AND FAIRGROVE WAY (OLIVE ROAD TO SEVEN GABLES AVENUE); AND AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH SAID CONTRACTOR TO COMPLETE PHASE II OF THE 2026 PAVING PROGRAM FOR AN AMOUNT NOT TO EXCEED \$591,537.45.

WHEREAS, the City is repairing and resurfacing various roadways in the City;
and

WHEREAS, the City properly advertised Phase II of the 2026 Paving Program project as required by law and the bid of Neyra Construction, Inc. (“Neyra”), was determined to be the lowest and best bid submitted; and

WHEREAS, the City Manager and the Public Works Project Manager recommend that City Council authorize the City Manager to enter into an agreement with Neyra to complete the work necessary for the above-described pavement repair and resurfacing project for an amount not to exceed \$591,537.45.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:

SECTION I: The City solicited bids for Phase II of the 2026 Paving Program to include pavement repairs and resurfacing work to be completed on Seven Gables Avenue (Fairgrove Way to Sylvan Oak Drive), Sylvan Oak Drive (Horrell Road to Dead End), Chaplen Drive (Patrick Street to Skinner Drive), Burman Avenue (Glenside Court to Olive Road), Post Town Road (North Union Road to City Corp. Limits), and Fairgrove Way (Olive Road to Seven Gables Avenue).

SECTION II: The bids were reviewed and the City Manager and Public Works Project Manager recommend that City Council accept the bid of Neyra Construction, Inc. (“Neyra”) for the above-described repair and resurfacing work.

SECTION III: City Council finds that the bid of Neyra was the lowest and best bid submitted and, therefore, accepts the same.

SECTION IV: City Council authorizes the City Manager to enter into an agreement with Neyra to complete the work necessary for the above-described repair and resurfacing project for an amount not to exceed \$591,537.45.

SECTION V: Funds have been appropriated in the Street Income Tax Fund (Fund 219) or are in the process of collection in an amount sufficient to pay the authorized contract amount.

SECTION VI: This Resolution shall take effect and be in full force from and after the date of its passage.
