

**RESOLUTION NO. R25-14****A RESOLUTION BY THE TROTWOOD CITY COUNCIL  
APPROVING REVISIONS TO THE BYLAWS OF THE FIRST  
SUBURBS CONSORTIUM OF DAYTON OHIO, A COUNCIL OF  
GOVERNMENTS.**

**WHEREAS**, the consortium known as the First Suburbs Consortium of Dayton Ohio (the “Consortium”), is a Council of Governments that was formed in 2005 pursuant to Chapter 167 of the Ohio Revised Code, and

**WHEREAS**, the Consortium’s current Bylaws, approved by City Council by Resolution No. R17-71, became effective on July 17, 2017; and

**WHEREAS**, the Consortium’s Governing Board unanimously approved revisions to the Bylaws on October 23, 2024; and

**WHEREAS**, Section XIII of the July 17, 2017 Bylaws require the newly revised Bylaws be approved by the member communities; and

**WHEREAS**, it is the recommendation of Trotwood Vice Mayor Tyna Brown, Council’s appointed representative serving on the Consortium in her official capacity, that Council approve the proposed revisions to the Consortium’s Bylaws attached hereto and incorporated herein by reference as Exhibit “A”.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE  
CITY OF TROTWOOD, STATE OF OHIO:**

**SECTION I:** The proposed revisions to the Bylaws of the First Suburbs Consortium of Dayton Ohio, attached hereto and incorporated herein as Exhibit “A”, are hereby approved.

**SECTION II:** The Clerk of Council is hereby directed to forward a certified copy of this Resolution to the Executive Director of the First Suburbs Consortium of Dayton Ohio.

**SECTION III:** This Resolution shall take effect and be in force from and after the date of its passage.
