

RESOLUTION NO. R24-106

A RESOLUTION BY THE TROTWOOD CITY COUNCIL AUTHORIZING THE CITY OF TROTWOOD TO HOLD A PLANNING SESSION TO BEGIN THE PROCESS TO BECOME AN “AGE-FRIENDLY COMMUNITY” TO SERVE THE PUBLIC PURPOSE OF PROMOTING STRONG COMMUNITY RELATIONS, WITH EXPENDITURES NOT TO EXCEED TWO HUNDRED DOLLARS (\$200.00).

WHEREAS, the Trotwood City Council recognizes the importance of reinforcing strong community relations by promoting City-sponsored initiatives; and

WHEREAS, City-sponsored initiatives help foster strong community relations, thereby serving a valid public purpose in the State of Ohio and in the City; and

WHEREAS, the City is embarking on an initiative to become an “Age-Friendly Community” through the AARP Network of Age-Friendly States and Communities. This designation represents a multi-year planning effort focused on recognizing and enhancing the age-friendly and livable aspects of the Trotwood community; and

WHEREAS, to support this initiative, the City was awarded a \$15,000.00 grant from the Dayton Foundation Del Mar Healthcare Fund to be used to hire a consultant to conduct a comprehensive livability assessment for the City so to identify the needs and opportunities for creating a more livable and age-friendly community; and

WHEREAS, the steering committee for this initiative will hold a planning session with the consultant on Wednesday, December 11, 2024 to begin the first step of the process to become an “Age-Friendly Community.” The meeting will be held from 11:00 a.m. to 1:00 p.m. at the Trotwood Community and Cultural Arts Center, 4000 Lake Center Drive, Trotwood, OH 45426, with a light lunch to be provided.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:

SECTION I:

The Trotwood City Council hereby determines that the planning session to support the “Age-Friendly Community” initiative is intended to serve the public purpose of fostering strong community relations, which serves a valid public purpose in the State of Ohio and in the City. The initial planning session shall be held on Wednesday, December 11, 2024 from 11:00 a.m. to 1:00 p.m.
