

## **RESOLUTION NO. R26-14**

**A RESOLUTION BY THE TROTWOOD CITY COUNCIL FOR FINAL LEGISLATION AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT WITH THE OHIO DEPARTMENT OF TRANSPORTATION TO IMPROVE PEDESTRIAN ACCESS ALONG OLIVE ROAD AND ENHANCE THE INTERSECTION OF OLIVE ROAD AND STATE ROUTE 49, PROJECT ID NO. 117202.**

**WHEREAS**, the City of Trotwood, hereinafter referred to as the Local Public Agency (“LPA”), enacts this Final Resolution for the project known by the State of Ohio Department of Transportation (“ODOT”) as Trotwood Olive Rd Walks SA22, Project ID No. 121597; and

**WHEREAS**, on the 5th day of May, 2025, the LPA enacted legislation, Resolution No. R25-36, proposing cooperating with the Ohio Director of Transportation for the described project:

*Improvement of pedestrian access along Olive Road by adding 1,500 feet of new sidewalk and the reconstruction of a traffic signal at the intersection of Salem Avenue (State Route 49) and Olive Road, including pavement planning, asphalt concrete surfacing, curb, curb ramps, traffic signal upgrades, and pavement markings, within the City of Trotwood (the “Project”).*

**WHEREAS**, the LPA shall cooperate with the Director of Transportation in the Project as follows:

*The City agrees to assume and bear one hundred percent (100%) of the entire cost of the improvement within the City limits, less the amount of Federal-Aid funds set aside by the Ohio Director of Transportation for the financing of this improvement from funds allocated by the Federal Highway Administration, U.S. Department of Transportation.*

The share of the cost of the LPA is now estimated in the amount of Two Hundred Fourteen Thousand Eight Hundred and 00/100 Dollars (\$214,800.00), but said estimated amount is to be adjusted in order that the LPA’s ultimate share of said improvements shall correspond with said percentages of actual costs when said actual costs are determined; and

**WHEREAS**, the Director of Transportation has approved said legislation proposing cooperation and has caused to be made plans and specifications and an estimate of cost and expense for improving the above-described highway and has transmitted copies of the same to this legislative authority; and

**WHEREAS**, the LPA desires the Ohio Director of Transportation to proceed with the aforesaid highway improvement.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:**

**SECTION I:** The estimated sum of Two Hundred Fourteen Thousand Eight Hundred and 00/100 Dollars (\$214,800.00) is hereby appropriated for the Project described above and the Fiscal Officer is hereby authorized and directed to issue an order on the treasurer for said sum upon the requisition of the Director of Transportation to pay the cost and expense of said improvement. The Fiscal Officer's Certificate regarding the appropriated funds is attached hereto and incorporated herein as Exhibit "A".

**SECTION II:** We hereby agree to assume in the first instance, the share of the cost and expense over and above the amount to be paid from Federal funds.

**SECTION III:** The LPA hereby requests the Director of Transportation to proceed with the aforesaid highway improvement.

**SECTION IV:** The LPA shall enter into a contract with the State, and the City Manager is hereby authorized to execute said contract, providing for the payment of the LPA, the sum of money set forth herein above for improving the Project.

**SECTION V:** The LPA shall transmit to the Director of Transportation a fully executed copy of this Resolution.

**SECTION VI:** This Resolution shall take effect and be in full force from and after the date of its passage.
