

**RESOLUTION NO. R25-46****A RESOLUTION BY THE TROTWOOD CITY COUNCIL TO CERTIFY DELINQUENT CHARGES FOR STORM DRAINAGE SERVICE AGAINST A CERTAIN PARCEL OF PROPERTY TO THE AUDITOR OF MONTGOMERY COUNTY, OHIO, FOR PLACEMENT ON THE TAX DUPLICATE.**

**WHEREAS**, the owner of a certain parcel of property situated in the City of Trotwood has unpaid storm drainage bills and all attempts to collect the outstanding charges have been unsuccessful; and

**WHEREAS**, the charges owed by the owner of the property known as 6750 Little Richmond Road, Parcel No. H33 02303 0043, as set forth in the document attached hereto and incorporated herein as Exhibit "A", are past due and now delinquent; and

**WHEREAS**, in accordance with the City of Trotwood Codes of Ordinances, Chapter 927, it is necessary to collect these unpaid storm drainage bills by certifying the delinquent charges, together with a 10% administrative fee charged by the City of Trotwood and any other interest and penalties allowed by law, to the Montgomery County Auditor for placement on the tax duplicate.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:**

**SECTION I:**

The City Manager or his designee is hereby authorized to certify delinquent charges, together with a 10% administrative fee charged by the City of Trotwood and any other interest and penalties allowed by law, owed to the City of Trotwood against the property known as 6750 Little Richmond Road, Parcel No. H33 02303 0043, for unpaid storm drainage bills in the total amount of Sixty-Six Dollars and No Cents (\$66.00), as set forth in the document attached to and incorporated herein as Exhibit "A", for placement on the tax duplicate.

**SECTION II:**

A copy of this Resolution, together with Exhibit "A", shall be certified by the Clerk of Council to the Auditor of Montgomery County, Ohio, to be placed on the tax duplicate and collected as other taxes are collected according to law.
