

RESOLUTION NO. R20-98

A RESOLUTION BY THE TROTWOOD CITY COUNCIL AUTHORIZING THE CITY MANAGER TO DECLARE LADDER 73, A 2010 PIERCE ARROW XT 105' AERIAL, FROM THE TROTWOOD FIRE AND RESCUE DEPARTMENT AS OBSOLETE AND/OR SURPLUS AND NO LONGER NEEDED FOR A PUBLIC PURPOSE AND AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT WITH BRINDLEE MOUNTAIN FIRE APPARATUS, LLC FOR THE PURCHASE OF LADDER 73 FOR A PRICE OF \$278,220.00.

WHEREAS, the Trotwood Fire/EMS Chief has determined that Ladder 73, a 2010 Pierce Arrow XT 105" Aerial, from the Fire and Rescue Department is obsolete and/or surplus and no longer needed for a public purpose; and

WHEREAS, the City Manager agrees that Ladder 73, which belongs to the City of Trotwood, is obsolete and/or surplus and is no longer needed for any public purpose; and

WHEREAS, the City sought proposals for the purchase of this obsolete and/or surplus equipment as required by law; and

WHEREAS, the Fire/EMS Chief is requesting this obsolete and/or surplus aerial ladder truck be sold to Brindlee Mountain Fire Apparatus ("BMFA") for a price of \$278,220.00, subject to final adjustment for any damage to the ladder truck prior to final sale; and

WHEREAS, the City Manager recommends that City Council declare Ladder 73 obsolete and/or surplus and authorize the City Manager to enter into a contract with BMFA for BMFA to purchase Ladder 73 for a price of \$278,220.00, subject to final adjustment for any damage to the ladder truck prior to sale.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:

SECTION I:

The Trotwood City Council hereby finds and determines that Ladder 73, a 2010 Pierce Arrow XT 105" Aerial, is obsolete and/or surplus and is no longer needed for a public purpose.

SECTION II:

The City Manager is hereby authorized to enter into a contract with BMFA for BMFA to purchase Ladder 73 for a price of \$278,220.00, subject to final adjustment for any damage to the ladder truck prior to final sale.

SECTION III:

This Resolution shall take effect and be in full force from and after the date of its passage.
