**RESOLUTION NO. R26-42**

**A RESOLUTION BY THE TROTWOOD CITY COUNCIL AUTHORIZING THE CITY MANAGER TO ENTER INTO AN LPA FEDERAL ODOT-LET PROJECT AGREEMENT WITH THE OHIO DEPARTMENT OF TRANSPORTATION ACCEPTING FEDERAL FUNDS IN AN AMOUNT NOT TO EXCEED \$810,663.00 TO RESURFACE TURNER ROAD FROM SALEM AVENUE TO WOLF ROAD, PROJECT ID NO. 126204.**

**WHEREAS**, the City determined there is a need to resurface Turner Road from Salem Avenue to Wolf Road; and

**WHEREAS**, the City applied for and was awarded Federal funds through the Surface Transportation Program in an amount not to exceed \$810,663.00 from the Ohio Department of Transportation (“ODOT”), to be combined with local funds in the amount of \$310,509.00, for a total project cost of \$1,121,172.00 to mill and resurface Turner Road from Salem Avenue to Wolf Road; and

**WHEREAS**, the Deputy City Manager and the Public Works Supervisor recommend that the Trotwood City Council authorize the City Manager to enter into the LPA Federal ODOT-LET Project Agreement with ODOT for the purpose of resurfacing Turner Road from Salem Avenue to Wolf Road.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:**

**SECTION I:** City Council accepts the recommendation of the Deputy City Manager and Public Works Supervisor and hereby authorizes the City Manager to enter into the LPA Federal ODOT-LET Project Agreement that is substantially similar in form as the Agreement attached hereto and incorporated herein as Exhibit “A”.

**SECTION II:** The City was awarded and accepts Federal funds through the Surface Transportation Program in an amount not to exceed \$810,663.00 from ODOT to mill and resurface Turner Road from Salem Avenue to Wolf Road.

**SECTION III:** This Resolution shall take effect and be in force from and after the date of its passage.
