

**RESOLUTION NO. R26-36**

**A RESOLUTION BY THE TROTWOOD CITY COUNCIL AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH THE OHIO DEPARTMENT OF TRANSPORTATION ACCEPTING FEDERAL FUNDING TO IMPROVE THE INTERSECTION AT STATE ROUTE 49 AND LITTLE RICHMOND ROAD, PROJECT NO. 126489.**

**WHEREAS**, the City determined there is a critical need to improve the intersection at State Route 49 and Little Richmond Road to address safety concerns; and

**WHEREAS**, The City applied for and has been awarded Federal funding through the Ohio Department of Transportation (“ODOT”) for the purpose of redesigning the intersection at State Route 49 and Little Richmond Road to enhance traffic safety and operational efficiency; and

**WHEREAS**, the MOT-SR 49/Little Richmond RD IMP Project (the “Project”), Project No. 126489, is estimated to cost a total of \$537,566.00, with the City required to contribute funding up to 10% of the total Project cost; and

**WHEREAS**, the City Manager recommends that City Council authorize the City Manager to enter into an Agreement with ODOT to accept Federal funding for the Project at a cost not to exceed \$537,566.00, with the City required to contribute funding up to 10% of the total cost.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:**

**SECTION I:** City Council hereby authorizes the City Manager to accept Federal funding through the Ohio Department of Transportation, which funds shall be utilized to improve the intersection at State Route 49 and Little Richmond Road at a total Project cost not to exceed \$537,599.00, with the City required to contribute funding up to 10% of the total Project cost.

**SECTION II:** Funds have been appropriated or are in the process of collection for the City’s requisite share of the total cost of the Project.

**SECTION III:** A copy of said Agreement is attached hereto and incorporated herein as Exhibit “A”.
