

RESOLUTION NO. R26-32

**A RESOLUTION BY THE TROTWOOD CITY COUNCIL
AUTHORIZING THE CITY MANAGER TO DECLARE
CERTAIN OBSOLETE AND/OR SURPLUS INFORMATION
TECHNOLOGY EQUIPMENT AS NO LONGER NEEDED FOR A
PUBLIC PURPOSE AND AUTHORIZING SAID EQUIPMENT TO
BE DONATED AND/OR OTHERWISE DISPOSED OF.**

WHEREAS, the City’s Information Technology (“IT”) contractor has determined that certain IT equipment for the City of Trotwood can no longer be utilized because the equipment is unsupported, abandoned, or antiquated, and has been replaced by newer and/or better technology; and

WHEREAS, the City Manager agrees that certain IT equipment belonging to the City has reached the end of its useful life and is obsolete and/or surplus, and no longer needed for any public purpose; and

WHEREAS, the IT Contractor has requested these obsolete and/or surplus items be donated and/or otherwise disposed of; and

WHEREAS, the City Manager recommends that Council declare the items obsolete and/or surplus and authorize the items in the document attached hereto and incorporated herein as “Exhibit A” to be donated and/or otherwise disposed of.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:

SECTION I: City Council hereby finds that the property listed in “Exhibit A,” which is attached hereto and incorporated herein by reference, is unsupported, abandoned, or antiquated, and is obsolete and/or surplus, and no longer needed for any public purpose.

SECTION II: The City Manager is hereby authorized to have the equipment listed in the attached “Exhibit A” donated and/or otherwise disposed of.

SECTION III: This Resolution shall take effect and be in full force from and after the date of its passage.
