

**RESOLUTION NO. R25-43**

**A RESOLUTION BY THE TROTWOOD CITY COUNCIL AUTHORIZING THE CITY MANAGER TO ACCEPT A GRANT THROUGH THE FISCAL YEAR 2024 ASSISTANCE TO FIREFIGHTERS GRANT PROGRAM FROM THE DEPARTMENT OF HOMELAND SECURITY, IF AWARDED, FOR THE PURPOSE OF PURCHASING PORTABLE VENTILATORS AND PORTABLE SUCTION UNITS FOR THE TROTWOOD FIRE AND RESCUE DEPARTMENT.**

**WHEREAS**, the City of Trotwood, Ohio, anticipates receiving a grant award through the Fiscal Year (“FY”) 2024 Assistance to Firefighters Grant Program from the Department of Homeland Security in the amount of \$142,887.27 for the purpose of purchasing portable ventilators and portable suction units for the Trotwood Fire and Rescue Department; and

**WHEREAS**, if awarded said grant, the City is required to contribute funding in an amount equal to or greater than 10% of the federal grant fund awarded, which represents a contribution of no less than \$14,288.73 from the City, for a total projected budget of approximately \$157,176.00; and

**WHEREAS**, the City Manager recommends that the Trotwood City Council authorize the City Manager to accept the grant funds from the Department of Homeland Security, if awarded.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:**

**SECTION I:**

The Trotwood City Council authorizes the City Manager to accept funds through the FY 2024 Assistance to Firefighters Grant Program from the Department of Homeland Security, if awarded, in the amount of \$142,887.27 for the purpose of purchasing portable ventilators and portable suction units for the Trotwood Fire and Rescue Department.

**SECTION II:**

If awarded said grant, the City of Trotwood is required to contribute funding in an amount equal to or greater than 10% of the federal grant funds awarded, which requires a contribution of no less than \$14,288.73 from the City.

**SECTION III:**

Funds have been appropriated in the amount of \$14,288.73 for the City's requisite 10% share of the total cost of the purchase of portable ventilators and portable suction units for the Trotwood Fire and Rescue Department.

**SECTION IV:**

This Resolution shall take effect and be in full force from and after the date of its passage.
