Mr. Stephen Offord introduced the leadership of Troop 44 and shared information about Scouting America. He explained that they are looking for ideas on how to attract youth to scouting. He stated they want to increase their exposure in the community and participate in events when available . Mr. Offord discussed the over 135 merit badges that scouts can earn and the rank of Eagle Scout. He stated that the Scouting America program prepares youth to become responsible, participating citizens, and leaders. He added that Troop 44 meets on Monday evenings from 7:00 - 8:30 p.m. at Phillips Temple South.

Council Member Moore asked how many scouts are currently on the roster. Mr. Offord said they have three scouts on their roster and commented that attracting youth is difficult. Council Member Moore then asked if they've presented this information to the Trotwood school district. Mr. Thomas Wilz, Troop 44 Scoutmaster, stated that they have worked with the schools, but it doesn't seem to produce the number of participants he believes is out there. He shared that his call is now to the parents and grandparents in hopes that the morals taught in the program may appeal more so to them. He said the difference from when a youth begins the program to when they may become an eagle scout is incredible.

Council Member Moore suggested contacting the school board president to find out how best to work with the superintendent to connect with parents.

Council Member Kelley thanked Mr. Offord for his presentation and shared that he likes the suggestions made as a path for youth to follow and be connected with the community.

Mayor Page reiterated how active their group already is in the community and that she hopes by attending this meeting they receive some exposure. She went on to explain that as a City, leadership has to be careful because there are many organizations available to youth and she must be fair to everyone. Mayor Page reminded Mr. Offord that they are welcome to participate in events and suggested he work with Charles Wheeler (Marketing Coordinator) to help promote their program.

Mr. Raymond Goodwin of 5637 Mount Olive Court addressed Council, stating that he was recently tagged for having trailers on his property and wanted to know how many complaints the City received in order to ban trailers in the City of Trotwood. He shared that he is a landscaper and plows snow for a living and owns two trailers, and it will cost him around \$2,400 a year to keep them at a storage facility. He stated that people with more land have campers, boats, trailers, ATVs, yet he has to move his two trailers. Mr. Goodwin asked why anyone would move to Trotwood with a regulation like this. He went on to explain that he was told he cannot appeal the violation and that there is a fine of \$150; he asked if the fine is per week, per quarter, per year. He suggested he could just pay the fine since it would be cheaper than paying for storage. He shared that his written violation reads trash and debris; it says nothing about trailers. Mr. Goodwin would like to know if there is going to be any amendments to this policy.

Mayor Page recommended Mr. Goodwin speak with Mr. Tyler Hauck; Mr. Goodwin shared that he has already spoke with Mr. Hauck. City Manager Pope thanked Mr. Goodwin for coming forward with his concern. He shared he and his staff are evaluating the rule and like any rule, just because it is written on paper doesn't mean it can't be changed. He advised Mr. Goodwin to speak with Deputy City Manager Kellum if he needs any additional information.
