RESOLUTION NO. R26-34

A RESOLUTION BY THE TROTWOOD CITY COUNCIL AUTHORIZING THE CITY MANAGER TO ENTER INTO AN ECONOMIC DEVELOPMENT/GOVERNMENT EQUITY (ED/GE) PROGRAM PROJECT AGREEMENT WITH MONTGOMERY COUNTY ACCEPTING FUNDS TO SUPPORT AN ECONOMIC DEVELOPMENT PROJECT IN THE CITY OF TROTWOOD.

WHEREAS, the City applied for and was awarded from Montgomery County, [REDACTED] from their 2026 Primary Economic Development Fund to provide funding support for the [REDACTED] in the City of Trotwood; and

WHEREAS, effective March 20, 2026, Section 9.66 of the Ohio Revised Code provides that certain information previously disseminated by a public office or official shall now be exempt from disclosure and not considered a public record under Ohio law; and

WHEREAS, the applicant, [REDACTED], has executed a written waiver and authorization permitting the disclosure and use of its name and the amount of funding awarded to satisfy legislative approval and public transparency requirements; and

WHEREAS, the City Manager recommends City Council authorize the City Manager to enter into the Economic Development/Government Equity (ED/GE) Program Project Agreement with Montgomery County.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:

SECTION I: City Council accepts the recommendation of the City Manager and hereby authorizes the City Manager to enter into an ED/GE Program Project Agreement with Montgomery County.

SECTION II: This agreement allows the City to provide funding support in an amount not to exceed [REDACTED] to the [REDACTED] to accommodate the continued growth of the company's production facility by acquiring a facility in the City of Trotwood for the indoor cultivation, processing, and packaging of specialty products.
