Clerk Landis clarified with Council Member Moore if she was asking to amend the Consent Agenda by removing said resolutions; Council Member Moore confirmed that she wanted to remove Resolution Nos. R26-08 and R26-09 from the Consent Agenda. Clerk Landis advised that removing items from the Consent Agenda should be done prior to the vote and stated her requested action would require a Motion to approve an amended Consent Agenda removing Resolution Nos. R26-08 and R26-09, and placing them under the Resolutions section of the Agenda for further discussion. Mayor Page asked Council for unanimous consent to retract the initial motion, to which Council verbally agreed. Mayor Page then asked for said Motion. Clerk Landis stated there were no public comments on this ordinance.

City Manager Pope advised that staff is proposing to update Section 505.17 "Barnyard Animals" of the Code to allow the keeping of barnyard animals in appropriate areas, such as the agricultural zoning district. He explained that this regulation has not been updated since 1987, prior to the merger, and under the current regulations, once farmland in former Madison Township is sold to a new owner, the property is not permitted to keep any type of barnyard animals typically associated with farming or agriculture. He summarized that this update would allow citizens in agriculturally zoned areas to keep barnyard animals.

Director Hauck reiterated City Manager Pope's comments.

**City Manager Pope** shared that this is an application from the Derringer Family Farm to rezone 3.082 acres of an existing 93.02-acre tract of farmland. The subject property is currently zoned Light Industrial 1 and is located near Strawberry Court and State Route 49. The applicant is requesting the rezoning to change it to Residential Single-Family, Low Density and combine it with their existing home to the north. The applicant wishes to use the property for personal recreation reasons and to possibly restart the previously existing tree farm.

**Director Hauck** shared maps to show the location of the subject parcels of land. He went on to explain that although combining lots does not go through Council, the two parcels of land are in different zoning districts, creating split zoning. Therefore, rezoning the property before combining the parcels is necessary.

**Council Member Pearson** asked for the meaning of low density. Director Hauck explained that it is a zoning classification for single-family homes with a lot size requirement of around 20,000 square feet.

**Mayor Page** asked for clarification, restating that this change increases the residential area, and that both parcels have the same owner. Director Hauck confirmed her statements to be correct.

Clerk Landis advised there were no public comments.

City Manager Pope stated that this legislation authorizes the City Manager to execute a contract with the State to upgrade sidewalks on Olive Road and redesign the SR49 and Olive Road intersection. He went on to say that this project is expected to be advertised in early 2026, with construction beginning around the third quarter of 2026, if no delays occur. City Manager Pope shared that the project is expected to be completed in 2027 with a total estimated cost of \$1.2 million.

**City Manager Pope reiterated the caption of the legislation, explaining that the \$50,000 covers fees associated with three performances, rental of portable restrooms, security, equipment rental, tents, permits, trash receptacles, and other necessary supplies.**

**Council Member Finley asked City Manager Pope what costs are incurred when performers are selected. City Manager Pope stated that the performers are paid a fee, which is included in the \$50,000. Council Member Finley asked when there are cancellations or changes in the contract, are those funds returned to the City. City Manager Pope shared that they are currently working on a refund from the last show in 2025 that was cancelled.**

**Council Member Moore reiterated questions about what happens when a scheduled concert is cancelled and commented there were two concerts cancelled in 2025. City Manager Pope stated that there is also a provision in the contract for rescheduling.**

**Marketing Coordinator Wheeler explained that the contract states the City will reschedule events cancelled due to acts of God. However, he went on to say that although the concert in July was cancelled due to weather, the City made the decision to cancel the concert for safety reasons; therefore, the City was not able to get a refund.**

**Council Member Moore then mentioned the second cancellation, to which Marketing Coordinator Wheeler stated that it was cancelled by the artist and the City is in the process of receiving a refund. City Manager Pope explained that in this instance, the artist and the promoter had a disagreement that had nothing to do with the City. He added that he spoke with both parties and rather than be in the middle of their disagreement, he made the decision to cancel the event. He then contacted the law department to have notices issued to the promoters.**

**Council Member Moore asked if there will be more detailed provisions for such instances in future contracts. City Manager Pope stated that staff is currently working with the law department so that the City has more control going forward.**

**Council Member Pearson asked if there is a time limit on rescheduling cancelled events. Marketing Coordinator Wheeler said that there is no such restriction currently in the contact, but that is something they may look at for this year.**

**Law Director Conard added that they are reevaluating the entire process in light of what has been learned over the last two seasons, to include using our**

own contracts, not theirs.

**Council Member Moore asked if each performance costs around \$17,000. Marketing Coordinator Wheeler agreed, and confirmed that the City is out the money for one of the cancellations.**

**City Manager Pope shared that staff is also looking at local talent. Council Member Moore added that maybe a variety of music could be offered.**

**Mayor Page requested a Motion to approve Resolution No. R26-08, with the particulars to be handled by the City Manager and his staff. A Motion was made by Council Member Moore, seconded by Vice Mayor Brown, and the Motion CARRIED by the following vote:**

**XIV. Comments**

A. PUBLIC COMMENTS: To comment on a topic not scheduled for a Public Hearing, please fill out a Speaker Form and return it to the Clerk of Council BEFORE the start of the meeting. When called upon, proceed to the microphone, state your name and address, and proceed with your comments. You will have three (3) minutes to speak.

Mr. Ernest Curry of 5420 Northford Road introduced himself as the President of Westbrook Homes Association, and explained that he is appearing before Council to share concerns about the City's enforcement of Section 351.14 of the Code, which is the parking of trucks and trailers. He stated that this ordinance requires that all trucks and trailers be removed from City streets, and he understands applying this to commercial trucks, and also commercial trailers. However now, no trailers of any kind are allowed to be parked on the street. Previously they were told non-commercial trailers had to be in your driveway. He went on to say that recently, notices have been posted advising that trailers have to be removed from driveways, as well as any part of the property that is not zoned for commercial purposes. He reiterated that these are trailers for personnel use, non-commercial trailers. Mr. Curry shared that he researched the matter and explained the difference between commercial and non-commercial trailers, and that although the state allows municipalities to have the authority to pass such ordinances, they normally make allowances for personal-use trailers to be parked on the side of homes or in the backyard, but they cannot be on grass. Mr. Curry is requesting that Council reconsider this ordinance and make accommodations for residents of the City who own trailers to be allowed to keep those trailers on their personal property. He went on to say that not allowing residents to keep their personal use trailers on their property is a burden to those residents as it requires rentable storage spaces, possibly creating a hardship for those who own trailers.

Mayor Page thanked Mr. Curry for coming forward and recognized his due diligence regarding this issue. She stated that Council will take his comments into consideration and get with Tyler Hauck and the City Manager for further discussion.

JoAnne Orihood of 14 Oak Street expressed her disappointment in the lack of holiday decorations and asked the City to think about doing more this year. She commented that in the past, residents have decorated certain public areas, and suggested maybe groups could be created within each Ward to participate in such activities.

B. Clerk of Council

There were no announcements.

## C. City Manager

**City Manager Pope** reminded the public that they are who drives public policy and the City carries out what it is that the public wants. He explained that in regards to parking, the public was complaining about trucks parked on the street in their neighborhoods and on the new roadways, which as we all know, the City is trying to get paved. He went on to say that the City responded to what the public said. He gave another example of people complaining about others leaving their trash cans out for 24 hours, so staff presented an ordinance creating a fine for those in violation; that was also in response to the public.

**D. Council Members**

**Council Member Moore** asked **City Manager Pope** if there has been any word on the behavioral health center site along the lines of the community-focused meetings hosted by the State as she has spoken with some people about those meetings.

**City Manager Pope** responded stating that an e-mail was sent to the State on December 30th asking when they would be holding these meetings, and also about receiving answers to the City's 34 questions. He shared that he received a response yesterday simply acknowledging the e-mail, but no further information or answers.

**Council Member Moore** shared that she is asking because the **Harrison Township Trustees** are talking about having tentative dates for community focus groups to answer questions about the project. **Mayor Page** asked **Council Member Moore** to share what information she has so that everyone knows the status. **Council Member Moore** said that the **Harrison Township Trustees** have tentative dates for community focus groups. **Mayor Page** asked if those meetings are for **Trotwood**. **Council Member Moore** responded that anyone can attend, but she would like to know from the **City Manager** about our dates; where's our follow-up/follow-through. She went on to say that she understands there is still opportunity for site visits, for elected officials and citizens. She then congratulated those returning to their seats and prevailing in their elections; she welcomed **Council Member Kelley** and congratulated **Vice Mayor Brown**.

**Council Member Finley** welcomed back **Council Member Kelley** and congratulated **Council Member Clark**, **Council Member Brown**, and **Council Member Pearson**, and she looks forward to working alongside them.

**Council Member Kelley** thanked everyone who helped him with his campaign, and shared that he came back to support the **Trotwood** community, for personal/spiritual reasons, and to support **City Manager Pope** and **Mayor Page**. He went on to express his frustration with things he saw at the polling sites. **Council Member Kelley** went on to say that a countless amount of voters were turned away from being able to vote because their polling location had changed, but they never received notice of a polling change from the **Montgomery County Board of Elections**. **Council Member Kelly** said that he shared his concerns with the **Mayor** and **City Manager**, then consulted with the **NAACP**, and went on to file a complaint with the **Board of Elections**. He explained that his biggest concern is with the upcoming mid-term elections, and although he doesn't know if this community was being targeted, he is concerned these may be efforts to suppress votes.

**Council Member Clark** congratulated all of her fellow **Council Members** who were elected during this cycle, then shared that she witnessed the same issues as **Council Member Kelley** did and is also frustrated. She stated that some voters were told their new polling location; however, many others were not and that is a problem. **Council Member Clark** thanked everyone who supported her during her campaign.

**Council Member Pearson** welcomed **Council Member Kelley** and said he is

looking forward to working together. He mentioned the mental health facility, and commented that talking about and around Trotwood, is not talking with Trotwood. He added that he agrees with JoAnne Orihood's comments and would like to see more holiday decorations.

Vice Mayor Brown congratulated all who prevailed and she is excited to be a part of the team; she also welcomed back Council Member Kelley. She thanked all of the citizens who voted for her and her colleagues who entrust her to be the vice mayor. Council Member Brown said that she is deeply honored to serve.

E. Mayor

Mayor Page acknowledged all of Council and shared that there are no other people she would rather work with. She suggested to surround yourself with people who are positive and that everyone on Council brings something to the table. Mayor Page stated that she is proud to serve with these individuals and she is proud to be the Mayor. She went on to say she is excited about 2026, then mentioned the mental health hospital. She explained that the City wants the mental health hospital as it is going to bring the City tax dollars; however, the math doesn't work with the numbers that have been provided. She shared that she is willing to listen and collaborate, but no one is going to just come to Trotwood and do what they want to do.
