

RESOLUTION NO. R25-61

A RESOLUTION BY THE TROTWOOD CITY COUNCIL AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH CHOICE ONE ENGINEERING CORPORATION FOR THE WESTBROOK AND HOKE ROADS INTERSECTION ROUNDABOUT PROJECT, A JOINT SAFETY PROJECT WITH THE CITY OF CLAYTON, OHIO, AT A COST NOT TO EXCEED \$217,665.80, WHICH INCLUDES THE CONTRACT PRICE OF \$18,850.00, PLUS A 10% CONTINGENCY AMOUNT OF \$1,885.00, FOR THE DESIGN ENGINEERING COSTS; AND THE TOTAL PROJECT COST OF \$179,028.00, PLUS A 10% CONTINGENCY AMOUNT OF \$17,902.80.

WHEREAS, the City of Clayton was awarded a grant through the Ohio Department of Transportation's ("ODOT") Safety Program for the design and construction of a roundabout at the intersection of Hoke and Westbrook Roads (the "Westbrook and Hoke Roads Intersection Roundabout Project"); and

WHEREAS, the Westbrook and Hoke Roads Intersection Roundabout Project is a joint safety project with the City of Clayton; and

WHEREAS, the grant awarded by ODOT for the Westbrook and Hoke Roads Intersection Roundabout Project was \$3,222,504.00; and

WHEREAS, the City of Trotwood and the City of Clayton are responsible for \$358,056.00 of the cost of the Westbrook and Hoke Roads Intersection Roundabout Project, with each City's share being \$179,028.00; and

WHEREAS, the design engineering costs for the Westbrook and Hoke Roads Intersection Roundabout Project is estimated at \$377,000.00, and the City of Trotwood and the City of Clayton are responsible for \$37,700.00 of the design engineering costs, with each City's share being \$18,850.00; and

WHEREAS, the City Manager and the Public Works Operations Manager recommend that City Council authorize the City Manager to enter into an agreement with Choice One Engineering Corporation for the Westbrook and Hoke Roads Intersection Roundabout Project at a cost not to exceed \$217,665.80, which includes the contract price of \$18,850.00, plus a 10% contingency amount of \$1,885.00, for the design engineering costs; and the total project cost of \$179,028.00, plus a 10% contingency amount \$17,902.80.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:

SECTION I:

City Council hereby authorizes the City Manager to enter into an agreement with Choice One Engineering Corporation to complete the work necessary for the Westbrook and Hoke Roads Intersection Roundabout Project for an amount not to exceed \$217,665.80, which includes the contract price of \$18,850.00, plus a 10% contingency amount of \$1,885.00, for the design engineering costs; and the total project cost of \$179,028.00, plus a 10% contingency amount of \$17,902.80.

SECTION II:

Funds have been appropriated or are in the process of collection in an amount sufficient to pay the authorized contract amount.

SECTION III:

This Resolution shall take effect and be in force from and after the date of its passage.
