

RESOLUTION NO. R26-19

A RESOLUTION BY THE TROTWOOD CITY COUNCIL RATIFYING ALL ACTIONS TAKEN ACCEPTING THE BID OF L.J. DEWEESE CO., INC. FOR WATER MAIN REPLACEMENT AND RELATED WORK ON EPPINGTON DRIVE AND MACMILLAN DRIVE; AND RATIFYING ALL ACTIONS TAKEN ENTERING INTO AN AGREEMENT WITH SAID CONTRACTOR TO COMPLETE PHASE ONE AND PHASE TWO OF THIS PROJECT FOR AN AMOUNT NOT TO EXCEED \$2,603,399.12, WHICH IS THE CONTRACT AMOUNT OF \$2,366,726.47, PLUS A 10% CONTINGENCY AMOUNT OF \$236,672.65.

WHEREAS, the City has determined it is necessary to replace aging water lines and several fire hydrants on portions of Eppington Drive and MacMillan Drive through a series of phases; and

WHEREAS, the City properly advertised the Eppington and MacMillan Water Main Replacement Project – Phases 1 & 2 as required by law, and the bid of L.J. DeWeese Co., Inc. (“DeWeese”) was determined to be the lowest and best bid submitted; and

WHEREAS, the City entered into an agreement with DeWeese to complete the work necessary for the above-described water main replacement project; and

WHEREAS, this resolution is presented to the Trotwood City Council to formally ratify all actions taken accepting the lowest and best bid submitted by DeWeese, and to formally ratify all actions taken entering into an agreement with said contractor to complete the Eppington and MacMillan Water Main Replacement Project – Phases 1 & 2, as the required legislative action was inadvertently omitted at the time of acceptance.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:

SECTION I: The City solicited bids for the Eppington and MacMillan Water Main Replacement Project – Phases 1 & 2 as required by law.

SECTION II: Bids were reviewed by the City and the City accepted the lowest and best bid submitted by L.J. DeWeese Co., Inc. (“DeWeese”) for the above-described water main replacement project.

SECTION III:

The City entered into an agreement with DeWeese to complete the work necessary for the Eppington and MacMillan Water Main Replacement Project – Phases 1 & 2, for an amount not to exceed \$2,603,399.12, which is the contract price of \$2,366,726.47 plus a contingency amount equal to 10% of the total contact price, or \$236,672.65.

SECTION IV:

City Council hereby ratifies all actions taken by the City accepting the lowest and best bid of DeWeese and entering into an agreement with said contractor for the Eppington and MacMillan Water Main Replacement Project – Phases 1 & 2.

SECTION V:

Funds have been appropriated in the Water Fund (Fund 601) or are in the process of collection in an amount sufficient to pay the authorized contract amount.

SECTION VI:

This Resolution shall take effect and be in full force from and after the date of its passage.
