

**ORDINANCE NO. OR01-26**

**AN ORDINANCE BY THE TROTWOOD CITY COUNCIL REPEALING CURRENT SECTION 505.17 “BARNYARD ANIMALS” OF THE TROTWOOD CODE OF ORDINANCES, AND ENACTING A NEW SECTION 505.17 “BARNYARD ANIMALS” TO ALLOW FOR BARNYARD ANIMALS IN DISTRICTS ZONED AGRICULTURAL (A) WITHIN THE CITY OF TROTWOOD.**

**WHEREAS**, the current Section 505.17 “Barnyard Animals” of the Trotwood Code of Ordinances does not permit barnyard animals of any kind within the City of Trotwood; and

**WHEREAS**, the keeping of barnyard animals is a traditional and customary agricultural activity that supports farming, local food production, and educational agricultural uses; and

**WHEREAS**, it would be beneficial to permit barnyard animals in districts zoned Agricultural (A) within the City of Trotwood to preserve and promote agricultural land uses, rural character, and farming practices essential to the community’s economic and environmental sustainability; and

**WHEREAS**, the City Manager recommends that Council repeal the current Section 505.17 “Barnyard Animals” of the Trotwood Codes of Ordinances and that a new Section 505.17 “Barnyard Animals” be enacted; and

**WHEREAS**, Council accepts the recommendation of the City Manager and, therefore, will repeal and replace Section 505.17 “Barnyard Animals” of the Trotwood Codes of Ordinances as set forth herein.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:**

**SECTION I:** The current Section 505.17 “Barnyard Animals” of the Trotwood Code of Ordinances is hereby repealed in its entirety.

**SECTION II:** A new Section 505.17 “Barnyard Animals” is hereby enacted as set forth in Exhibit “A” attached hereto and incorporated herein by reference, with additions in **bold** and underscored and deletions in ~~strikethrough~~.
