

**RESOLUTION NO. R26-15**

**A RESOLUTION BY THE TROTWOOD CITY COUNCIL  
APPOINTING THE 2026 CHARTER REVIEW COMMISSION  
FOR THE CITY OF TROTWOOD, STATE OF OHIO.**

**WHEREAS**, the Charter of the City of Trotwood, State of Ohio, Section 10-5 (“Amendment of Charter”), requires a Charter Review Commission be appointed by Council commencing in January of 1971 and every five (5) years thereafter; and

**WHEREAS**, Section 10-5 of the Charter requires Council to appoint a Charter Review Commission that shall consist of not less than five (5) nor more than nine (9) qualified electors of the City of Trotwood; and

**WHEREAS**, the Charter Review Commission is required to make a complete and thorough review of the Trotwood City Charter and make recommendations to Council as to any alterations, revisions, and amendments to the Trotwood City Charter that it deems advisable; and

**WHEREAS**, each Council Member submitted the name of one elector of the City of Trotwood, for a total of seven (7) members to be appointed to the Charter Review Commission, who have expressed a willingness to serve on this Charter Review Commission; and

**WHEREAS**, the Charter Review Commission appointed by Council pursuant to Section 10-5 of the Trotwood City Charter shall serve in this capacity up through and including the date of the November 2026 general election, unless Council releases each member of the Charter Review Commission from their official duties after the submission of their written recommendations to Council; and

**WHEREAS**, Council has created its *Policies and Procedures for the Trotwood Charter Review Commission* for the members of the 2026 Charter Review Commission to adhere to while performing their official duties concerning the 2026 Charter review; and

**WHEREAS**, the Charter Review Commission should submit its written report and recommendations regarding any of its proposed alterations, revisions and amendments to the Trotwood City Council on or before Friday, June 26, 2026.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:**

**SECTION I:**

Council hereby appoints the following citizens, who are over the age of eighteen and qualified electors of the City of Trotwood, to serve on the 2026 Charter Review Commission:

**SECTION II:**

Council hereby adopts the *Policies and Procedures for the Trotwood Charter Review Commission*, a copy of which is attached hereto and incorporated herein by reference as Exhibit “A.”

**SECTION III:**

Members of the 2026 Charter Review Commission shall adhere to the *Policies and Procedures for the Trotwood Charter Review Commission*. Further, each duly appointed member of the 2026 Charter Review Commission shall affix his or her signature on a copy of the *Policies and Procedures for the Trotwood Charter Review Commission* to acknowledge their receipt and review of the same.

**SECTION IV:**

The Charter Review Commission shall make its written report and recommendations to Council regarding any proposed alterations, revisions, and amendments to the Trotwood Charter on or before Friday, June 26, 2026.

**SECTION V:**

The duly appointed members of the 2026 Trotwood Charter Commission shall serve in this capacity up through and including the date of the November 2026 general election unless Council releases each member of the Charter Review Commission from his and her official duties after the submission of their written recommendations to Council.

**SECTION VI:** This Resolution shall take effect and be in force from and after the date of its passage.
