

RESOLUTION NO. R16-68

A RESOLUTION BY TROTWOOD CITY COUNCIL ACCEPTING THE BID OF BARRETT PAVING MATERIALS INC. FOR THE WORK TO BE COMPLETED FOR THE WOLF CREEK PIKE RESURFACING PROJECT (BRIDGE AT MAIN ST TO OLIVE RD)(PROJECT NO. 2016-05) AND AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH SAID CONTRACTOR TO COMPLETE PROJECT NO. 2016-05 FOR AN AMOUNT NOT TO EXCEED \$96,950.00.

WHEREAS, the City was awarded \$80,000.00 from a Montgomery County Community Development Block Grant (CDBG) to resurface Wolf Creek Pike between Main Street and Olive Road, create a 28 foot bike path running from the bridge on Main Street to George Street, and to install thermal pavement marking; and

WHEREAS, the City advertised for bids in July of 2016 for Project No. 2016-05 and the bid of Barrett Paving Materials Inc. was determined to be the lowest and best bid submitted; and

WHEREAS, the City Manager and the Public Works Operations Manager recommend that City Council authorize the City Manager to enter into an Agreement with Barrett Paving Materials Inc. to complete the work necessary for the Wolf Creek Pike Resurfacing Project (Project No. 2016-05) for an amount not to exceed \$96,950.00.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO, THAT:

SECTION I: The City solicited bids for the Wolf Creek Pike Resurfacing Project (Project No. 2016-05) in July of 2016.

SECTION II: The Public Works Operations Manager reviewed the bids for Project No. 2016-05 and recommends that Council accept the bid of Barrett Paving Materials Inc..

SECTION III: City Council finds the bid of Barrett Paving Materials Inc. to be the lowest and best bid submitted and, therefore, accepts the same.

SECTION IV: City Council authorizes the City Manager to enter into an Agreement with Barrett Paving Materials Inc. to complete the work for the Wolf Creek Pike Resurfacing Project (Project No. 2016-05) for an amount not to exceed \$96,950.00.

SECTION V: This Resolution shall take effect and be in full force from and

after the date of its passage.
