

**ORDINANCE NO. OR19-16**

**AN ORDINANCE TO APPROVE CURRENT REPLACEMENT PAGES  
TO THE TROTWOOD CODES OF ORDINANCES AND DECLARING  
AN EMERGENCY.**

WHEREAS, certain provisions within the Codes of Ordinances should be amended to conform with current State law as required by the Ohio Constitution; and

WHEREAS, various ordinances of a general and permanent nature have been passed by Council which should be included in the Codes of Ordinances; and

WHEREAS, the City has heretofore entered into a contract with the Walter H. Drane Company to prepare and publish such revision which is before Council;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO, THAT:

SECTION I: The ordinances of the City of Trotwood, Ohio, of a general and permanent nature, as revised, recodified, rearranged and consolidated into component codes, titles, chapters and sections within the 2016 Replacement Pages to the Codes of Ordinances are hereby approved and adopted.
