## **ORDINANCE NO. 04-17**

## AN ORDINANCE BY TROTWOOD CITY COUNCIL REPEALING OLD SECTION 1123.02 "DEFINITIONS" AND ENACTING NEW SECTION 1123.02 "DEFINITIONS" AND DECLARING AN EMERGENCY.

**WHEREAS**, Codified Ordinances Section 1123.02 of the City of Trotwood, Ohio provides the definitions for the Trotwood Zoning Code; and

**WHEREAS**, the Trotwood City Council has determined that it would be in the best interest of the City to adopt a new Section 1123.02 entitled "Definitions" of the Codified Ordinances of the City of Trotwood, Ohio to update the definitions in the Zoning Code to comply with the Fair Housing Act.

## NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO, THAT:

**SECTION I:** That Section 1123.02 "Definitions" in Chapter 1123 "Definitions"

of the Codified Ordinances of the City of Trotwood, Ohio be

repealed.

**SECTION II:** That a new Section 1123.02 "Definitions" in Chapter 1123

"Definitions" of the Codified Ordinances of the City of Trotwood, Ohio be enacted to read as set forth in Exhibit A with additions in **bold** and <u>underlined</u> and deletions in <u>strikethrough</u>, which is

attached hereto and incorporated herein.

**SECTION III:** It is hereby found and determined that all formal actions of this

Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that any and all deliberations of this Council that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including, but not limited to Section 121.22 of the

Ohio Revised Code.

**SECTION IV:** This Ordinance is hereby declared to be an emergency in order to

amend the Codified Ordinances to update the definitions in the Zoning Code to comply with the Fair Housing Act, which will preserve the public health, safety, and welfare. This Ordinance

shall take effect immediately upon adoption.
