

**ORDINANCE NO. 06-17**

**AN ORDINANCE BY TROTWOOD CITY COUNCIL REPEALING OLD SECTION 1181.05 "PARKING SPACE REQUIREMENTS" AND ENACTING NEW SECTION 1181.05 "PARKING SPACE REQUIREMENTS" AND DECLARING AN EMERGENCY.**

**WHEREAS**, Codified Ordinances Section 1181.05 of the City of Trotwood, Ohio provides parking space requirements for various uses throughout the City of Trotwood; and

**WHEREAS**, the Trotwood City Council has determined that it would be in the best interest of the City to adopt a new Section 1181.05 entitled "Parking Space Requirements" of the Codified Ordinances of the City of Trotwood, Ohio to update the parking space requirements to comply with the Fair Housing Act.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO, THAT:**

**SECTION I:** That Section 1181.05 "Parking Space Requirements" in Chapter 1181 "Off-Street Parking and Loading" of the Codified Ordinances of the City of Trotwood, Ohio be repealed.

**SECTION II:** That a new Section 1181.05 "Parking Space Requirements" in Chapter 1181 "Off-Street Parking and Loading" of the Codified Ordinances of the City of Trotwood, Ohio be enacted to read as set forth in Exhibit A with deletions in ~~striketrough~~, which is attached hereto and incorporated herein.

**SECTION III:** It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that any and all deliberations of this Council that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including, but not limited to Section 121.22 of the Ohio Revised Code.

**SECTION IV:** This Ordinance is hereby declared to be an emergency in order to amend the Codified Ordinances to update the parking space requirements to comply with the Fair Housing Act, which will preserve the public health, safety, and welfare. This Ordinance shall take effect immediately upon adoption.
