

**ORDINANCE NO. 08-17**

**AN ORDINANCE BY TROTWOOD CITY COUNCIL REPEALING OLD SECTION 1185.06 "TEMPORARY SIGNS (ADDITIONAL PERMITTED)" AND ENACTING NEW SECTION 1185.06 "TEMPORARY SIGNS (ADDITIONAL PERMITTED)" AND DECLARING AN EMERGENCY.**

**WHEREAS**, Codified Ordinances Section 1185.06 of the City of Trotwood, Ohio provides additional regulations for temporary signs within the City of Trotwood; and

**WHEREAS**, the Trotwood City Council has determined that it would be in the best interest of the City to adopt a new Section 1185.06 entitled "Temporary Signs (Additional Permitted)" of the Codified Ordinances of the City of Trotwood, Ohio to update the requirements for temporary signs to comply with changes in the law.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO, THAT:**

**SECTION I:** That Section 1185.06 "Temporary Signs (Additional Permitted)" in Chapter 1185 "Signs" of the Codified Ordinances of the City of Trotwood, Ohio be repealed.

**SECTION II:** That a new Section 1185.06 "Temporary Signs (Additional Permitted)" in Chapter 1185 "Signs" of the Codified Ordinances of the City of Trotwood, Ohio be enacted to read as set forth in Exhibit A with additions in **bold** and deletions in ~~strikethrough~~, which is attached hereto and incorporated herein.

**SECTION III:** It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that any and all deliberations of this Council that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including, but not limited to Section 121.22 of the Ohio Revised Code.

**SECTION IV:** This Ordinance is hereby declared to be an emergency in order to amend the Codified Ordinances to update the regulation of temporary signs to be in ordinance with changes in the law, which will preserve the public health, safety, and welfare. This Ordinance shall take effect immediately upon adoption.
