RESOLUTION NO. <u>17-37</u>

A RESOLUTION BY the TROTWOOD CITY COUNCIL AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH IAP-GSG, INC. FOR THE PROJECT MANAGEMENT OF THE TROTWOOD COMMUNITY AND CULTURAL ARTS CENTER FOR AN AMOUNT NOT TO EXCEED 8.5% OF THE TOTAL PROJECT COST.

WHEREAS, the City is in the process of renovating the Trotwood Community and Cultural Arts Center and the City was awarded a \$250,000.00 cultural facilities grant from the Ohio Facilities Construction Commission to aid in that renovation; and

WHEREAS, the City advertised for bids for project management of the Trotwood Community and Cultural Arts Center renovation and the bid of IAP- GSG, Inc. was determined to be the lowest and best bid submitted; and

WHEREAS, the City Manager recommends that City Council authorize the City Manager to enter into an Agreement with IAP-GSG, Inc. for project management of the Trotwood Community and Cultural Arts Center renovation for an amount not to exceed 8.5% of the total project cost.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO, THAT:

- **SECTION I:** The City solicited bids for the Trotwood Community and Cultural Arts Center renovation.
- **SECTION II:** The bids were reviewed and the City Manager recommends that Council accept the bid ofIAP-GSG, Inc..
- **SECTION III:** City Council finds the bid of IAP-GSG, Inc. to be the lowest and best bid submitted and, therefore, accepts the same.
- **SECTION IV:** City Council authorizes the City Manager to enter into an agreement with IAP-GSG, Inc. for project management of the Trotwood Community and Cultural Arts Center renovation for an amount not to exceed 8.5% of the total project cost.
- **SECTION V:** This Resolution shall take effect and be in full force from and after the date of its passage.
