

RESOLUTION NO. 17-127

**A RESOLUTION BY TROTWOOD CITY COUNCIL AUTHORIZING
THE CITY MANAGER TO DECLARE CERTAIN OBSOLETE
AND/OR SURPLUS FIRE & RESCUE EQUIPMENT AS NO LONGER
NEEDED FOR A PUBLIC PURPOSE AND AUTHORIZING SAID
PROPERTY FROM THE TROTWOOD FIRE & RESCUE
DEPARTMENT TO BE SOLD ON GOVDEALS.COM**

WHEREAS, the Fire/EMS Chief has determined that certain equipment of the Trotwood Fire & Rescue Department is no longer being utilized due to damage, becoming obsolete, holding no value to the department, and the like; and

WHEREAS, the City Manager found this equipment belonging to the City is obsolete and/or surplus and is no longer needed for any public purpose; and

WHEREAS, the Fire/EMS Chief has requested these obsolete and/or surplus items be sold on govdeals.com or propertyroom.com; and

WHEREAS, the obsolete and/or surplus fire equipment is fully set forth in the document attached to this Resolution as Exhibit "A"; and

WHEREAS, the City Manager recommends Council declare the items surplus and authorize the items set forth on the attached Exhibit "A" be sold on govdeals.com or propertyroom.com.

SECTION I: Council hereby finds and determines that the property listed in Exhibit "A" attached hereto and incorporated herein is obsolete and/or surplus and is no longer needed for municipal purposes.
