## **RESOLUTION NO. 18-04**

A RESOLUTION BY TROTWOOD CITY COUNCIL AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH BUCKEYE FLOORING FOR THE FLOORING WORK TO BE COMPLETED AT THE TROTWOOD COMMUNITY AND CULTURAL ARTS CENTER RENOVATION FOR AN AMOUNT OF \$66,616.70.

**WHEREAS**, the City is in the process of renovating the Trotwood Community and Cultural Arts Center; and

**WHEREAS**, the City advertised for bids for the flooring work to be completed at the Trotwood Community and Cultural Arts Center and no bids were received; and

**WHEREAS**, after no bids were received, three proposals were obtained and Buckeye Flooring provided the lowest and best proposal; and

**WHEREAS**, the City Manager recommends that City Council authorize the City Manager to enter into an Agreement with Buckeye Flooring for the flooring work to be completed at the Trotwood Community and Cultural Arts Center for an amount of \$66,616.70.

## NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO, THAT:

**SECTION I:** The City solicited bids for the Trotwood Community and Cultural Arts Center flooring work and no bids were received.

**SECTION II:** The City obtained three proposals and the City Manager recommends that Council accept the proposal of Buckeye Flooring.

**SECTION III:** City Council finds the proposal of Buckeye Flooring to be the lowest and best proposal submitted and, therefore, accepts the same.

SECTION IV: City Council authorizes the City Manager to enter into an agreement with Buckeye Flooring in a form as approved by the Law Director for flooring work to be completed at the Trotwood Community and Cultural Arts Center for an amount of \$66,616.70.

**SECTION V:** This Resolution shall take effect and be in full force from and after the date of its passage.
