

**ORDINANCE NO. 07-18**

**AN ORDINANCE BY TROTWOOD CITY COUNCIL PROHIBITING THE  
CULTIVATION, PROCESSING, AND DISPENSING OF MEDICAL  
MARIJUANA WITHIN THE CITY OF TROTWOOD, OHIO.**

**WHEREAS**, the Ohio Legislature has legalized medical marijuana cultivators, processors and dispensaries within the State of Ohio; and

**WHEREAS**, for the purposes of this Ordinance, the definitions of “cultivators,” “processors,” and “dispensaries” are given the same definitions as those found in Ohio Administrative Code Section 3796:1-1-01; and

**WHEREAS**, Ohio Revised Code Section 3796.29 authorizes a municipality to limit the number of, or entirely prohibit, cultivators, processors, and dispensaries licensed pursuant to Ohio Revised Code Section 3796.29 in the City of Trotwood; and

**WHEREAS**, on March 5, 2018, Council determined that to help ensure the public peace, health, safety and welfare of its citizens, the cultivation, processing, and retail dispensing of medical marijuana shall be entirely prohibited within the City of Trotwood.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO THAT:

**SECTION I:**           The Trotwood City Council hereby prohibits the cultivation, processing, and retail dispensing of medical marijuana in the City of Trotwood, Ohio.

**SECTION II:**       It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that any and all deliberations of this Council that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including, but not limited to Section 121.22 of the Ohio Revised Code.

**SECTION III:**       This Ordinance shall take effect and be in force from and after the date of its passage.
