**Report for April, 2018**

- 1) Councilman Robert L. Kelley provided a few bags of Easter candy for the annual Easter Egg Hunt for the City of Trotwood. This event was held at Madison Park, 301 S. Broadway Street.
- 2) Councilman Kelley was one of three interviewers of a volunteer candidate for the Board of Zoning Appeals. The candidate interviewed well and would certainly love to be a Board Member for this committee.
- 3) The Public Safety Committee met Tuesday, April 10, 2018. Two reports were given. Chief E. Wilson gave a report which covered the following range of subjects:
  - a) Accreditation Program Update
  - b) 2017 Annual Report
  - c) Staffing/Hiring Updates

He passed out a very informative manual that covered the Organizational Chart, Budget, and Different Divisional Platoons, as well as the Specialty Departments (Canine, Motor Patrol, RedFlex, Accident Investigation, Internal Affairs).

Then the Fire Chief, Mr. Haacke, gave a report which addressed:

- 5) I received a call in the form of a complaint from a business owner who is located at 4596 Salem Avenue. He was very upset that a speed sign had been put recently in front of his business sign. He expressed that it reduced the productivity of his business. I gave the City Manager this information to look into the matter to see what could be done. Two-to-three days later Mr. Pope and the business owner told me the problem had been resolved. The sign was moved to another area. Great job, Mr. Pope!
- 6) On April 19, 2018 I attended the Dayton and Montgomery County Black Elected Officials Meet-and-Greet event at The Taste Restaurant, which is located in the City of Trotwood. Several other City of Trotwood Council Members and the Mayor were in attendance. Great event!
