A RESOLUTION BY TROTWOOD CITY COUNCIL ACCEPTING THE BID OF JOHN R. JURGENSEN COMPANY FOR THE RESURFACING WORK TO BE COMPLETED ON N. UNION ROAD (SHILOH SPRINGS ROAD TO WESTBROOK ROAD), OLIVE ROAD (W. THIRD STREET TO CORPORATION LINE), WOLF CREEK PIKE (DIAMOND MILL ROAD TO NOLAN ROAD), SNYDER ROAD (LITTLE RICHMOND ROAD TO SNAKE ROAD), LUTHERAN CHURCH ROAD (LITTLE RICHMOND ROAD TO WOLF CREEK PIKE), AND OLIVE ROAD (SALEM AVENUE TO SALEM BEND) AND AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH SAID CONTRACTOR TO COMPLETE THE PROJECT FOR AN AMOUNT NOT TO EXCEED \$857,493.62 WHICH IS A CONTRACT PRICE OF \$779,539.656 PLUS A CONTINGENCY AMOUNT OF 10% (\$77,953.97)

WHEREAS, the City of Trotwood has decided to pave or repair various stretches of roads within the City; and

WHEREAS, the City of Trotwood advertised for bids in May of 2018 for this resurfacing project, and the bid of John R. Jurgensen Company was determined to be the lowest and best bid submitted; and

WHEREAS, the Deputy City Manager and the Public Works Supervisor recommend that City Council authorize the City Manager to enter into an Agreement with John R. Jurgensen Company to complete this resurfacing project for an amount not to exceed \$857,493.62.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:

SECTION I:

The City of Trotwood solicited bids in May of 2018 for a resurfacing project to include work to be completed on N. Union Road (Shiloh Springs Road to Westbrook Road), Olive Road (W. Third Street to Corporation Line), Wolf Creek Pike (Diamond Mill Road to Nolan Road), Snyder Road (Little Richmond Road To Snake Road), Lutheran Church Road (Little Richmond Road To Wolf Creek Pike), and Olive Road (Salem Avenue To Salem Bend).

The Deputy City Manager and the Public Works Supervisor Manager reviewed the bids and recommends that Council accept the bid of John R. Jurgensen Company.
