

**RESOLUTION NO. R18-50**

**A RESOLUTION AUTHORIZING THE CITY MANAGER TO DECLARE CERTAIN OBSOLETE AND/OR SURPLUS FIRE & RESCUE AND EQUIPMENT AS NO LONGER NEEDED FOR A PUBLIC PURPOSE AND AUTHORIZING SAID PROPERTY FROM THE TROTWOOD FIRE & RESCUE DEPARTMENT TO BE DONATED TO THE MIAMI VALLEY CAREER TECHNOLOGY CENTER FIREFIGHTER TRAINING PROGRAM**

**WHEREAS**, the Fire/EMS Chief has determined that certain equipment of the Trotwood Fire & Rescue Department is no longer being utilized due to damage, becoming obsolete, holding no value to the department, and the like; and

**WHEREAS**, the City Manager found this equipment belonging to the City is obsolete and/or surplus and is no longer needed for any public purpose; and

**WHEREAS**, the Fire/EMS Chief has requested these obsolete and/or surplus items be donated to the Miami Valley Career Technology Center Firefighter Training Program; and

**WHEREAS**, the obsolete and/or surplus fire equipment is fully set forth in the document attached to this Resolution as Exhibit "A"; and

**WHEREAS**, the City Manager recommends Council declare the items surplus and authorize the items set forth on the attached Exhibit "A" be donated to the Miami Valley Career Technology Center Firefighter Training Program.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO THAT:**

**SECTION I:**

Council hereby finds and determines that the property listed in Exhibit "A" attached hereto and incorporated herein is obsolete and/or surplus and is no longer needed for municipal purposes.

**SECTION II:**

The City Manager is hereby authorized to have the property listed in the attached Exhibit "A" be donated to the Miami Valley Career Technology Center Firefighter Training Program.

**SECTION III:**

This Resolution shall take effect and be in force from and after the date of its passage.
