**A RESOLUTION BY TROTWOOD CITY COUNCIL  
AUTHORIZING THE CITY MANAGER TO ACCEPT A GRANT  
THROUGH THE FY2017 ASSISTANCE TO FIREFIGHTERS  
GRANT PROGRAM FROM THE DEPARTMENT OF  
HOMELAND SECURITY FOR THE PURPOSE OF  
PURCHASING CARDIAC MONITORS, AUTOMATED  
EXTERNAL DEFIBRILLATORS, AND SELF-CONTAINED  
BREATHING APPARATUS**

**WHEREAS**, the City has been awarded a grant through the FY2017 Assistance to Firefighters Grant Program from the Department of Homeland Security in the amount of \$338,182.00 for the purpose of purchasing cardiac monitors, automated external defibrillators, and self-contained breathing apparatus; and

**WHEREAS**, the City is required to provide 10% matching funds in the amount of \$33,818.00; and

**WHEREAS**, the City Manager recommends that City Council authorize the City Manager to accept the grant funds from the Department of Homeland Security.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO, THAT:**

**SECTION I:** City Council authorizes the City Manager to accept grant funds through the FY2017 Assistance to Firefighters Grant Program from the Department of Homeland Security in the amount of \$338,182.00 for the purpose of purchasing cardiac monitors, automated external defibrillators, and self-contained breathing apparatus.

**SECTION II:** Funds have been appropriated in the amount of \$33,818.00 for the City's matching share.

**SECTION III:** This Resolution shall take effect and be in full force from and after the date of its passage.
