

**RESOLUTION NO. R18-54**

**A RESOLUTION BY THE COUNCIL OF THE CITY OF  
TROTWOOD, OHIO, TO CERTIFY DELINQUENT  
WATER, SEWER, TRASH AND STORM DRAINAGE  
BILLS TO THE AUDITOR OF MONTGOMERY  
COUNTY, STATE OF OHIO FOR PLAC MENT ON THE  
MONTGOMERY COUNTY PROPERTY TAX  
DUPLICATE.**

**WHEREAS**, certain property owners in the City of Trotwood, Ohio, have delinquent water, sewer, trash, and storm drainage bills and all attempts to collect these outstanding amounts have been unsuccessful; and

**WHEREAS**, pursuant to the City of Trotwood Codes of Ordinances, Chapters 921, 923, 927, and 929, it is necessary to collect these delinquent water, sewer, trash and storm drainage bills by certifying these amounts to the Auditor of Montgomery County, State of Ohio, for placement on the property tax duplicate of said County, along with the interest and penalties allowed by law; and

**WHEREAS**, a list of the delinquent accounts showing parcel identification number and the amounts unpaid are attached hereto, made a part thereof, and incorporated herein by reference as EXHIBIT #1.

**NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE  
CITY OF TROTWOOD, MONTGOMERY COUNTY, STATE OF OHIO,  
THAT:**

**SECTION I**           The Finance Director is hereby authorized to assess delinquent charges to property owners, who have delinquent amounts of water, sewer, trash, and storm drainage bills as attached hereto, made a part thereof, and incorporated herein by reference as Exhibit # 1, shall be certified by the Clerk of this Council to the Auditor of Montgomery County, State of Ohio, to be placed on the 2018 tax duplicate and collected in 2019 as other taxes are collected, according to law, including interest and penalties. Payments received at the City of Trotwood by Friday, September 7, 2018 at 5:00 p.m., the close of business, shall not be certified, but removed from this list.

**SECTION II**       This Resolution shall take effect and be in full force immediately upon its adoption by Council.
