

Broadest Coverage Document in Ohio

PEP provides coverage to and for the following:

Broad definition of a member which includes:

- Any member of your governing body
- Any member of your boards or commissions
- Any elected or appointed official
- Any employee acting within the scope of their employment
- Any volunteer or student who performs a service for you at your request

Legal Liability -- Third Party Claims- \$2,000,000 Limit / \$10,000 Deductible

Applies to claims alleging:

Wrongful Acts (Public Officials) Liability \$2,000,000 Limit / \$10,000 Deductible
