A RESOLUTION BY THE TROTWOOD CITY COUNCIL APPROVING THE APPLICATION FOR THE PLACEMENT OF 49.059 ACRES OF LAND OWNED BY THOMAS L. & DONNA F. BROOKS IN THE AGRICULTURAL TAX DISTRICT, SAID PROPERTY 430 NORTH SNYDER ROAD, DAYTON, OHIO 45427 (PARCEL NO. H33-02309-0006) IN ACCORDANCE WITH O.R.C. CHAPTER 929, THE FARMLAND PRESERVATION ACT.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO, THAT:

<u>SECTION I:</u>	The Trotwood City Council hereby approves the application for placement of the property owned by Thomas L. & Donna F. Brooks, 49.059 acres as described in the application filed with the City, in accordance with the Farmland Preservation Act which provides a farm owner the following:
	 Act which provides a farm owner the following: Deferment of water sewer and electrical assessments:

- 1) Deferment of water, sewer, and electrical assessments;
- 2) Limited protection for lawsuits alleging nuisance; and
- 3) Limited protection from eminent domain proceedings.
- **SECTION II:** The placement of real property in an agricultural tax district does not change the current zoning of the property.

SECTION III: This Resolution shall take effect and be in force from and after the date of its passage.
