

**ORDINANCE NO. OR22-18**

**AN ORDINANCE ADOPTING NEW CHAPTER 931 “SMALL CELL FACILITIES & WIRELESS SUPPORT STRUCTURES” OF THE CITY OF TROTWOOD CODE OF ORDINANCES**

**WHEREAS**, Ohio House Bill 478 of the 132<sup>nd</sup> General Assembly (“HB 478”) was enacted affecting municipality regulation of small cell facilities, wireless facilities, and wireless support structures; and

**WHEREAS**, City staff recommended adopting a new section of the City of Trotwood Code of Codified Ordinances to address small cell, wireless facilities, and wireless support structures within the City of Trotwood to comply with HB 478, and to codify general procedures and standards for the siting, construction, placement, collocation, modification, operation, and removal of the same within the City of Trotwood; and

**WHEREAS**, Council accepts these recommendations and herein adopts New Chapter 931 of the City of Trotwood Code of Codified Ordinances

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO THAT:**

**SECTION I.**

New Section 931 (“Small Cell Facilities & Wireless Support Structures”) is hereby adopted as set forth in Exhibit A attached hereto and incorporated herein by reference.

**SECTION II.**

It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that any and all deliberations of this Council that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including, but not limited to Section 121.22 of the Ohio Revised Code.

**SECTION III.**

This Ordinance shall take effect at the earliest date allowed by law.
