

RESOLUTION NO. R18-82

**A RESOLUTION BY TROTWOOD CITY COUNCIL AUTHORIZING
THE CITY MANAGER TO DECLARE CERTAIN OBSOLETE
AND/OR SURPLUS FIRE & RESCUE EQUIPMENT AS NO LONGER
NEEDED FOR A PUBLIC PURPOSE AND AUTHORIZING SAID
PROPERTY FROM THE TROTWOOD FIRE & RESCUE
DEPARTMENT TO DONATED TO THE MIAMI VALLEY FIRE/EMS
ALLIANCE FOR REGION 3 RESCUE STRIKE TEAM**

WHEREAS, the Fire/EMS Chief has determined that certain equipment of the Trotwood Fire & Rescue Department is no longer being utilized due to damage, becoming obsolete, holding no value to the department, and the like; and

WHEREAS, the City Manager found this equipment belonging to the City is obsolete and/or surplus and is no longer needed for any public purpose; and

WHEREAS, the Fire/EMS Chief has requested these obsolete and/or surplus items be donated to Miami Valley Fire/EMS Alliance for Region 3 Rescue Strike Team; and

WHEREAS, the obsolete and/or surplus fire equipment is fully set forth in the document attached to this Resolution as Exhibit "A"; and

WHEREAS, the City Manager recommends Council declare the items surplus and authorize the items set forth on the attached Exhibit "A" be donated to Miami Valley Fire/EMS Alliance for Region 3 Rescue Strike Team

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO THAT:

SECTION I: Council hereby finds and determines that the property listed in Exhibit "A" attached hereto and incorporated herein is obsolete and/or surplus and is no longer needed for municipal purposes.

SECTION II: The City Manager is hereby authorized to have the property listed in the attached Exhibit "A" to be donated to the Miami Valley Fire/EMS Alliance for Region 3 Rescue Strike Team

SECTION III: This Resolution shall take effect and be in force from and after the date of its passage.
