

## **RESOLUTION R19-11**

### **A RESOLUTION BY THE COUNCIL OF THE TROTWOOD CITY COUNCIL APPOINTING MEMBERS TO THE COMMUNITY REINVESTMENT AREA HOUSING COUNCIL AS PROVIDED FOR IN ORDINANCE OR22-17.**

**WHEREAS**, the Council of the City of Trotwood, Ohio, pursuant to the Ohio Revised Code Sections 3735.66 to 3735.70, established and described the boundaries of a Community Reinvestment Area within the City of Trotwood, Ohio; and

**WHEREAS**, the Director of Economic Development and Planning has been designated as the Housing Officer as described in Section 3735.65 and 3735.66 of the Ohio Revised Code; and

**WHEREAS**, Ordinance OR22-17 provides that a Community Reinvestment Area Housing Council be established and consist of two (2) members appointed by the Mayor of the City of Trotwood, Ohio; two (2) members appointed by the Council of the City of Trotwood, Ohio; and One (1) member appointed by the Planning and Zoning Commission of the City of Trotwood, Ohio. The majority of the foregoing members shall then appoint two (2) additional members, who shall be residents within the area and boundaries set forth above,

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE  
CITY OF TROTWOOD, STATE OF OHIO, THAT:**

SECTION I      The Mayor of the City of Trotwood hereby appoints (2) two **Jay Young** and **Lynn Thomasson, Jr.** as his designees to serve on this Council for a three (3) year term.

SECTION II     The Council of the City of Trotwood hereby appoints **Rap Hankins** and **Fred Conway** as their designees to serve on this Council for a three (3) year term.

SECTION III    The Planning Commission of the City of Trotwood hereby appoints (1) one designee **Ernest Curry** to serve on this Council for a three (3) year term.

SECTION IV     This Resolution shall take effect immediately upon its adoption by Trotwood City Council.
