

**RESOLUTION NO. R18-74**

**A RESOLUTION BY TROTWOOD CITY COUNCIL ACCEPTING THE BID OF VOGELPOHL FIRE EQUIPMENT FOR THE PURCHASE OF 27 SELF CONTAINED BREATHING APPARATUS AND 34 ADDITIONAL FACE PIECES FOR THE TOTAL SUM OF \$168,319.00 WITH THE TOTAL CITY CONTRIBUTION OF 10% OR \$16,831.90 AND THE REMAINDER TO BE PAID FROM FEDERAL EMERGENCY MANAGEMENT AGENCY FIREFIGHTING ASSISTANCE GRANT AND AUTHORIZING THE CITY MANAGER**

**WHEREAS**, the City of Trotwood was awarded a FEMA grant to purchase self-contained breathing apparatus and additional face pieces; and

**WHEREAS**, the City of Trotwood advertised for bids and the bid of Vogelpohl Fire Equipment was determined to be the lowest and best bid submitted; and

**WHEREAS**, the City Manager and the Fire Chief recommend that City Council authorize the City Manager to enter into an Agreement with Vogelpohl Fire Equipment to for the purchase of self-contained breathing apparatus and additional face pieces.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:**

**SECTION I:** The City of Trotwood solicited bids for the purchase of self-contained breathing apparatus and additional face pieces.

**SECTION II:** The Fire Chief reviewed the bids and recommends that Council accept the bid of Vogelpohl Fire Equipment.

**SECTION III:** City Council finds the bid of Vogelpohl Fire Equipment to be the lowest and best bid submitted and, therefore, accepts the same.

**SECTION IV:** City Council authorizes the City Manager to enter into an Agreement with Vogelpohl Fire Equipment for the purchase of 27 self-contained breathing apparatus and 34 additional face pieces for the total sum of \$168,319.00 with the total city contribution of 10% or \$16,831.90 and the remainder to be paid from Federal Emergency Management Agency Firefighting Assistance Grant.

**SECTION V:** This Resolution shall take effect and be in force from and after the date of its passage.
