RESOLUTION NO. R18-75

A RESOLUTION BY TROTWOOD CITY COUNCIL ACCEPTING THE BID OF STRYKER/PHYSIO-CONTROL FOR THE PURCHASE OF 7 CARDIAC MONITORS AND 2 AUTOMATED EXTERNAL DEFIBRILLATORS FOR THE TOTAL SUM OF \$153,330.25 WITH THE TOTAL CITY CONTRIBUTION OF 10% OR \$15,333.03 AND THE REMAINDER TO BE PAID FROM FEDERAL EMERGENCY MANAGEMENT AGENCY FIREFIGHTING ASSISTANCE GRANT AND AUTHORIZING THE CITY MANAGER

WHEREAS, the City of Trotwood was awarded a FEMA grant to purchase cardiac monitors and automated external defibrillators; and

WHEREAS, the City of Trotwood advertised for bids and the bid of Stryker/Physio-Control was determined to be the lowest and best bid submitted; and

WHEREAS, the City Manager and the Fire Chief recommend that City Council authorize the City Manager to enter into an Agreement with Stryker/Physio-Control for the purchase of cardiac monitors and automated external defibrillators.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:

SECTION I: The City of Trotwood solicited bids for the purchase of cardiac

monitors and automated external defibrillators.

SECTION II: The Fire Chief reviewed the bids and recommends that Council

accept the bid of Stryker/Physio-Control.

SECTION III: City Council finds the bid of Stryker/Physio-Control to be the

lowest and best bid submitted and, therefore, accepts the same.

SECTION IV: City Council authorizes the City Manager to enter into an

Agreement with Stryker/Physio-Control for the purchase of 7 cardiac monitors and 2 automated external defibrillators for the total sum of \$153,330.25 with the total city contribution of 10% or \$15,333.03 and the remainder to be paid from Federal Emergency Management Agency Firefighting Assistance Grant.

SECTION V: This Resolution shall take effect and be in force from and after

the date of its passage.
