

**RESOLUTION NO. R19-51**

**A RESOLUTION AUTHORIZING THE CITY MANAGER TO DECLARE CERTAIN OBSOLETE AND/OR SURPLUS FIRE & RESCUE AND EQUIPMENT AS NO LONGER NEEDED FOR A PUBLIC PURPOSE AND AUTHORIZING SAID PROPERTY FROM THE TROTWOOD FIRE & RESCUE DEPARTMENT TO BE SOLD ON GOVDEALS.COM.**

**WHEREAS**, the Fire/EMS Chief has determined that certain equipment of the Trotwood Fire & Rescue Department is no longer being utilized due to damage, becoming obsolete, holding no value to the department, and the like; and

**WHEREAS**, the Fire/EMS Chief has requested these obsolete and/or surplus items be sold on govdeals.com; and

**WHEREAS**, the obsolete and/or surplus fire equipment is fully set forth in the document attached to this Resolution as Exhibit "A"; and

**WHEREAS**, the City Manager recommends Council declare the items surplus and authorize the items set forth on the attached Exhibit "A" be sold on govdeals.com.

**SECTION I:** Council hereby finds and determines that the property listed in Exhibit "A" attached hereto and incorporated herein is obsolete and/or surplus and is no longer needed for municipal purposes.
