A RESOLUTION BY TROTWOOD CITY COUNCIL AUTHORIZING THE CITY MANAGER TO ENTER INTO AN ECONOMIC DEVELOPMENT/GOVERNMENT EQUITY (ED/GE) PROGRAM PROJECT AGREEMENT WITH MONTGOMERY COUNTY TO RECEIVE \$23,000.00 IN GRANT FUNDING AWARDED TO THE CITY OF TROTWOOD FROM THE MONTGOMERY COUNTY'S PRIMARY ECONOMIC DEVELOPMENT FUND TO PROVIDE FUNDING SUPPORT FOR THE LR JANITORS, LLC DBA ROBINSON'S JANITORIAL & FLOOR CARE SERVICES LOCATE AT 5131 SALEM AVENUE, IN THE CITY OF TROTWOOD AND TO FURTHER ENTER INTO AN ECONOMIC DEVELOPMENT/GOVERNMENT EQUITY (ED/GE) PROGRAM PROJECT AGREEMENT WITH LR JANITORS, LLC DBA ROBINSON'S JANITORIAL & FLOOR CARE SERVICES

WHEREAS, the City Manager recommends City Council authorize the City Manager to enter into the ED/GE Agreement with Montgomery County; and

WHEREAS, as a condition of receiving the ED/GE grant, the City is also required to enter into an agreement with LR Janitorial, LLC dba Robinson's Janitorial & Floor Care Services; and

WHEREAS, the City Manager recommends City Council authorize him to prepare and finalize an agreement with LR Janitorial, LLC dba Robinson's Janitorial & Floor Care Services.

The City Manager is authorized to enter into the ED/GE Agreement with Montgomery County in order to receive \$23,000.00 in ED/GE grant funding from Montgomery County to provide funding support for the LR Janitorial, LLC dba Robinson's Janitorial & Floor Care Services expansion located at 5131 Salem Avenue in the City of Trotwood. This Agreement is attached hereto and incorporated herein as Exhibit "A".

SECTION II:	The City Manager recommends and is hereby authorized to negotiate an agreement with the applicant, LR Janitorial, LLC dba Robinson's Janitorial & Floor Care Services, which outlines the terms and conditions of the ED/GE grant. The terms of the Montgomery County agreement and the agreement with the applicant, LR Janitorial, LLC dba Robinson's Janitorial & Floor Care Services, is hereby approved subject to approval of the final agreements by the Law Director.
