

**RESOLUTION NO. R19-57**

**A RESOLUTION BY THE CITY COUNCIL AUTHORIZING THE  
RENAMING OF THE TROTWOOD COMMUNITY CENTER TO THE  
TROTWOOD COMMUNITY & CULTURAL ARTS CENTER AND  
DESIGNATING ROOMS AND APPLYING ROOM IDENTIFICATION  
SIGNS WITHIN THE BUILDING**

**WHEREAS**, City Council utilizes the building located at 4000 Lake Center Drive in Trotwood, Ohio for its regularly scheduled meetings and other public business; and

**WHEREAS**, this building has historically been known as the Trotwood Community Center; and

**WHEREAS**, City Council desires to change the name of the Trotwood Community Center to the Trotwood Community & Cultural Arts Center and to designate and apply room identification signs within the building; and

**WHEREAS**, the renaming of the building will help serve a public purpose by making the facility more inviting to the citizens of the City of Trotwood, which will help facilitate strong community relations.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO, THAT:**

**SECTION I.** City Council hereby authorizes the renaming of the Trotwood Community Center located at 4000 Lake Center Drive to the Trotwood Community & Cultural Arts Center.

**SECTION II.** City Council further authorizes the rooms and suites situated within the building to be named in accordance with the room and suite designations set forth in the building map attached hereto as Exhibit A.

**SECTION III.** City Council further authorizes the placement of the appropriate room identification signs outside each room and suite situated within the building.

**SECTION III.** This Resolution shall take effect and be in force from and after the date of its passage.
