A RESOLUTION BY TROTWOOD CITY COUNCIL AUTHORIZING THE TROTWOOD COMMUNITY IMPROVEMENT CORPORATION TO CONTINUE ITS FINANCIAL RELATIONSHIP WITH COUNTYCORP TO UTILIZE A REVOLVING LOAN FUND AND REQUEST AN INCREASE IN THE LINE OF CREDIT EFFECTIVE JULY 1, 2019

WHEREAS, the Trotwood Community Improvement Corporation (CIC) has an existing relationship with CountyCorp consisting of a revolving loan fund with a line of credit of One-Hundred Sixty Thousand Dollars (\$160,000.00) which matures on June 30, 2019; and

WHEREAS, the revenues from this fund are utilized by the CIC to acquire and stabilize properties and the funds are repaid from the proceeds of the sale of each property; and

WHEREAS, the Trotwood CIC Board of Directors request City Council authorize the continued financial relationship and loan program and further authorize the CIC Board of Directors to request an increase in the line of credit for a total line of credit of Two-Hundred Thousand Dollars (\$200,000.00) effective July 1, 2019.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO, THAT:

SECTION I:

City Council authorizes the Trotwood Community Improvement Corporation Board of Directors to continue this financial relationship and utilization of a revolving loan fund program funded through CountyCorp and further authorizes the Trotwood Community Improvement Corporation Board of Directors to request an increase in the line of credit for a total line of credit of Two-Hundred Thousand Dollars (\$200,000.00) effective July 1, 2019.
