## **RESOLUTION NO. R19-95**

A RESOLUTION BY TROTWOOD CITY COUNCIL ACCEPTING THE BID OF CG CONSTRUCTION COMPANY FOR THE OLIVE ROAD WATERLINE REPLACEMENT PHASE 1 PROJECT BCI NO. 19047 WORK TO BE COMPLETED ON OLIVE ROAD AND AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH SAID CONTRACTOR TO COMPLETE THE PROJECT FOR AN AMOUNT NOT TO EXCEED \$565,745.00 AND AUTHORIZING A 10% CONTRACT CONTINGENCY OF \$56,574.50 TO COVER UNANTICIPATED COSTS

**WHEREAS,** the City applied for and was awarded an OPWC Grant of up to \$439,448.00, or 74% of the project costs; and

WHEREAS, the City's share is 26% or up to \$155,000.00; and

**WHEREAS**, the City of Trotwood has decided to repair waterline on Olive Road within the City; and

**WHEREAS**, the City of Trotwood advertised for bids on May 5, 2019 and May 12, 2019 for this waterline replacement phase 1 project, and the bid of CG Construction Co., Inc. was determined to be the lowest and best bid submitted; and

**WHEREAS**, the Deputy City Manager and the Public Works Supervisor recommend that City Council authorize the City Manager to enter into an Agreement with CG Construction Co. to complete this resurfacing project for a contract amount of \$565,745.00 and authorize a 10% contract contingency of \$56,574.50.

## NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:

SECTION I: The City of Trotwood solicited bids on May 5, 2019 and May 12,

2019 for a replacement of 12" 8" 6" ductile iron waterline pipe & hydrants to include work to be completed on Olive Road.

Manager reviewed the bids and recommend that the Council accept

the bid of CG Construction Company.

SECTION III: City Council finds the bid of CG Construction Company to be the

lowest and best bid submitted and, therefore, accepts the same.

SECTION IV:	Agreement wi waterline repla	authorizes the City Manager to enter into an ith CG Construction Company to complete the accement project for \$565,745.00 and authorize a contingency of \$56,574.50.
