

**RESOLUTION NO. R19-99**

**A RESOLUTION AUTHORIZING THE REMOVAL OF  
ASSESSMENTS FROM THE MONTGOMERY COUNTY  
PROPERTY TAX DUPLICATE FOR CHARGES FOR  
DELINQUENT WATER, SEWER, TRASH, STORM  
WATER AND THE CUTTING AND REMOVAL OF  
WEEDS, VEGETATION AND/OR GRASS.**

WHEREAS, the City has previously submitted various delinquent charges for water, sewer, trash, storm water and the cutting and removal of weeds, vegetation and/or grass of property in the City of Trotwood, Ohio, to the Montgomery County Auditor's Office for placement on next property tax duplicate of the owner of said property; and

WHEREAS, some of those assessment were in error and a list of the assessments made in error is attached hereto as Exhibit "A" and made a part of the Resolution; and

WHEREAS, the City is requesting these assessments be removed from the tax duplicate.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO, THAT:

**SECTION I:** The City Manager is hereby authorized to request the Montgomery County Auditor remove from the property tax duplicate of the owners of the Property indexes on the list that is attached hereto as Exhibit "A" and made a part thereof, being Lots located in the City of Trotwood, Ohio.

**SECTION II:** This Resolution shall take effect and be in full force immediately upon its adoption by Council.

**SECTION III:** This Resolution shall take effect upon passage.
