

**RESOLUTION NO. R19-104**

**A RESOLUTION BY THE TROTWOOD CITY COUNCIL  
AUTHORIZING THE CITY MANAGER TO ENTER INTO  
THE MONTGOMERY COUNTY-INTERMUNICIPAL  
WASTE SERVICES AGREEMENT BETWEEN  
MONTGOMERY COUNTY, OHIO AND THE OTHER  
MEMBERS OF THE MONTGOMERY COUNTY SOLID  
WASTE DISTRICT**

**WHEREAS**, the City of Trotwood is a Member of the Montgomery County Solid Waste District by virtue of a Waste Delivery and Disposal Agreement it entered into in 1985; and

**WHEREAS**, the Montgomery County Solid Waste District has made significant changes to its operations over the years as a result of recommendations made by advisory committees as well as changes in federal and state law; and

**WHEREAS**, the Montgomery County Solid Waste District and its Members share a common goal of effectively managing solid waste, which is vital to the health, safety and welfare of the citizens of the City of Trotwood; and

**WHEREAS**, the Director of the Montgomery County Department of Environmental Services has presented the City with a new agreement for the Members of the Montgomery County Solid Waste District to sign in an effort to address the changes in federal and state law over the years as well as the recommendations of the advisory committees of the Montgomery County Solid Waste District; and

**WHEREAS**, City Council believes it is in the best interest of the citizens of the City of Trotwood that Trotwood continue to be a Member of the Montgomery County Solid Waste District and that it enter into the Montgomery County-Intermunicipal Waste Services Agreement attached hereto and incorporated herein as Exhibit A.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:**

**SECTION I:** Council hereby finds and determines that it is in the best interest of the public health, safety and welfare of the citizens of the City of Trotwood to enter into and adopt the Montgomery County-Intermunicipal Waste Services Agreement attached hereto and incorporated herein as Exhibit A.

**SECTION II:** The City Manager is hereby authorized to enter into the Montgomery County-Intermunicipal Waste Services Agreement attached hereto and incorporated herein as Exhibit "A" on behalf of the City of Trotwood.

**SECTION III:**

This Resolution shall take effect and be in force from and after the date of its passage.
