

RESOLUTION NO. R19-100

**A RESOLUTION AUTHORIZING THE
ASSESSMENT OF DELINQUENT CHARGES FOR
THE CUTTING AND REMOVAL OR
DESTRUCTION OF NOXIOUS VEGETATION TO
BE PLACED ON THE MONTGOMERY COUNTY
PROPERTY TAX DUPLICATE**

WHEREAS, the owners of property indexes on the list that is attached hereto and incorporated herein as Exhibit A, being lots in the City of Trotwood, Ohio, have been provided with written notice to cut and remove weeds, vegetation, and/or grass; and

WHEREAS, the owners of properties indexed on the list attached hereto and incorporated herein as Exhibit A, being lots located in the City of Trotwood, required the cutting and removal of weeds, vegetation and/or grass in order to be in compliance with the Trotwood Codified Ordinances; and

WHEREAS, all expenses and labor costs for the cutting, removal and/or destruction of the noxious weeds, vegetation and/or grass were incurred by the City of Trotwood and were paid with municipal funds; and

WHEREAS, these delinquent charges can be recovered by certification to the Montgomery County Auditor's Office for placement on the 2019 property tax duplicate to be collected in 2019 of said property owners.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE
CITY OF TROTWOOD, STATE OF OHIO:**

SECTION I. The City Manager is hereby authorized to certify delinquent charges in the amount of Eighty One Thousand Six Hundred Eighty Seven Dollars and Thirty Eight Cents (**\$81,687.38**) to the Montgomery County Auditor for placement on the property tax duplicate of the owners of the Property indexes on the list that is attached hereto and incorporated herein as Exhibit A, being lots located in the City of Trotwood, Ohio.

SECTION II. This Resolution shall take effect and be in full force immediately upon its adoption by Council.
