RESOLUTION NO. <u>R19-115</u>

A RESOLUTION BY THE COUNCIL OF THE CITY OF TROTWOOD, OHIO AUTHORIZING THE CITY MANAGER TO JOINTLY APPLY WITH THE CITY OF CLAYTON TO MIAMI VALLEY REGIONAL PLANNING COMMISSION ("MVRPC") FOR FUNDING FOR RESURFACING A PORTION OF WESTBROOK ROAD NOT TO EXCEED ONE HUNDRED FORTY THOUSAND DOLLARS (\$140,000.00).

WHEREAS, the City of Trotwood and City of Clayton share jurisdiction over Westbrook Road; and

WHEREAS, the City of Trotwood and the City of Clayton have agreed, subject to Council approval, to jointly apply to Miami Valley Regional Planning Commission ("MVRPC") to repave Westbrook Road; and

WHEREAS, in order to receive this funding, the City of Trotwood and the City of Clayton will be responsible for a portion of the repaying costs, which is Two Hundred Eighty Thousand Dollars (\$280,000); and

WHEREAS, the City of Clayton and City of Trotwood will split the Two Hundred Eighty Thousand Dollars (\$280,000.00) on a 50/50 basis with the City of Trotwood's costs for this project not to exceed One Hundred Forty Thousand Dollars (\$140,000.00).

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO THAT:

- **SECTION I:** The City Manager is hereby authorized to enter into a Cooperative Agreement with the City of Clayton to apply to MVRPC for funding to resurface a portion of Westbrook Road located between Salem Avenue and to Main Street, Clayton, Ohio, with a required contribution from the City of Trotwood and the City of Clayton of approximately Two Hundred Eighty Thousand Dollars (\$280,000.000) to be split on a 50/50 basis between the City of Trotwood and the City of Trotwood and the City of Clayton. The City of Trotwood's costs for this project shall not exceed One Hundred Forty Thousand Dollars (\$140,000.00).
- **SECTION II:** This Resolution shall take effect and be in force from and after the date of its passage.
