ORDINANCE NO. OR26-19

AN ORDINANCE ACCEPTING THE RECOMMENDATION OF THE TROTWOOD PLANNING COMMISSION TO AMEND THE CITY OF TROTWOOD ZONING MAP FOR THE AREA GENERAL ALONG SHILOH SPRINGS ROAD, EAST OF SR 49, SOUTH OF SALEM BEND AND DENLINGE ROAD, APPROXIMATELY 105 ACRES OF LAND FROM RSF-M (RESIDENTIAL SINGLE FAMILY-MEDIUM DENSITY) AND R-B (REGIONAL BUSINESS) DISTRICT TO G-B (GENERAL BUSINESS) DISTRICT (MAP ATTACHED).

WHEREAS, Council hereby finds the Planning Commission held a public hearing on July 23, 2019, in accordance with Section 1125.08 of the Codified Ordinances of the City of Trotwood, on the application of City of Trotwood, requesting to rezone the area general along Shiloh Springs Road, East of SR 49, South of Salem Bend and Denlinger Road, approximately 105 acres of land, map attached, from RSF-M (Residential Single Family-Medium Density) and R-B (Regional Business) District to G-B (General Business) District; and

WHEREAS, Planning Commission, after public hearing and discussion, voted and approved a motion recommending approval of the rezoning for said property; and

WHEREAS, City Council of the City of Trotwood, Ohio, held a public hearing, after notice of the time and place of the public hearing had been given as required by law; and

WHEREAS, City Council hereby finds that in order to foster the right development for the area generally known as the area around the old Salem Mall, there needs to be a set of regulations put in place to clearly articulate the City's expectations of the area going forward; and

WHEREAS, City Council hereby finds that the area generally known as the area around the old Salem Mall current zoning classification made sense when the area was previously a regional shopping designation; however, the retail market has shifted; and

WHEREAS, City Council hereby finds that rezoning for said property to G-B (General Business) District is intended to correct inconsistencies with the prior zoning designation and reflect general market trends going forward.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:

SECTION I:

The Trotwood City Council finds that the Planning Commission held a public hearing in accordance with Section 1125.08 of the Codified Ordinances of the City of Trotwood and hereby accepts the Planning Commission's recommendation to rezone the approximately 105 acres of land, as depicted on the attached map, and hereby grants the rezoning and amendment of the Official Zoning Map of the City of Trotwood for the area generally known as the area around the old Salem Mall along Shiloh Springs Road, East of SR 49, South of Salem Bend and Denlinger Road to G-B (General Business) District.
