

RESOLUTION NO. R19-96

A RESOLUTION BY THE CITY COUNCIL AUTHORIZING THE CITY MANAGER TO ENTER INTO A PUBLIC WORKS MUTUAL AID AGREEMENT WITH THE CITY OF CLAYTON AND ALL OTHER CITIES, VILLAGES AND TOWNSHIPS WILLING TO ENTER INTO MUTUAL AID AGREEMENTS WITH THE CITY OF TROTWOOD, AND FURTHER AUTHORIZING THE CITY MANAGER TO WORK WITH THE TROTWOOD LAW DIRECTOR TO RENEGOTIATE AND/OR MODIFY ANY MUTUAL AID AGREEMENTS ENTERED INTO BY THE CITY OF TROTWOOD AS NEEDED TO MEET ALL FEDERAL EMERGENCY MANAGEMENT AGENCY (FEMA) OR OTHER STATE AGENCY REQUIREMENTS

WHEREAS, City Council recognizes the importance of receiving assistance and aid from other cities, villages and townships in times of widespread disaster and emergency; and

WHEREAS, City Council further recognizes the importance of having Mutual Aid Agreements in place with these cities, villages and townships that wish to provide and receive aid when necessary in times of widespread disaster and emergency; and

WHEREAS, it is City Council's understanding that Mutual Aid Agreements must be in place in order for the City of Trotwood to submit a FEMA application in which it seeks reimbursement for mutual aid services provided to the City by another jurisdiction; and

WHEREAS, the City intends to submit applications to FEMA and/or state agencies that provide financial and/or other assistance to communities that have been stricken by natural or other disasters; and

WHEREAS, City Council wishes to empower the City Manager to take any and all action necessary with respect to these Mutual Aid Agreements to ensure that the City of Trotwood is able to secure assistance from FEMA and/or state agencies providing relief to communities in times of widespread disaster and emergency.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO, THAT:

SECTION I.

City Council hereby authorizes the City Manager to enter into the Mutual Aid Agreement attached hereto as Exhibit A with the City of Clayton, Ohio.

SECTION II.

City Council further authorizes the City Manager to enter into similar Mutual Aid Agreements with other cities, villages and townships as needed so that the City of Trotwood can receive from and provide assistance to other jurisdictions in times of natural or other disasters and emergencies.

SECTION III.

City Council further authorizes the City Manager, with the advice and counsel of the City Law Director, to renegotiate and modify any of these Mutual Aid Agreements as needed to ensure that these agreements are acceptable to and approved by FEMA and other state agencies with respect to applications made to these federal and state agencies for assistance and relief.

SECTION IV.

This Resolution shall take effect and be in force from and after the date of its passage.
