## AN ORDINANCE BY TROTWOOD CITY **COUNCIL** TRANSFERRING OWNERSHIP OF THE PROPERTY LOCATED AT THE FORMER SALEM MALL SITE, SPECIFICALLY PARCEL NO. H33 00514 0053, FROM THE CITY OF TROTWOOD TO THE TROTWOOD **COMMUNITY IMPROVEMENT CORPORATION.**

**WHEREAS**, the Trotwood Community Improvement Corporation ("TCIC") is the designated development agency, working on behalf of the City of Trotwood to create development opportunities in the Trotwood Community; and

**WHEREAS**, the City of Trotwood and the TCIC have an opportunity to encourage development of the above-described property in the City of Trotwood; and

**WHEREAS**, the City Council authorizes the transfer of property located at the former Salem Mall site, specifically Parcel No. H33 00514 0053, from the City of Trotwood to the TCIC; and

**WHEREAS**, City Council declares the property located at the former Salem Mall site, specifically Parcel No. H33 00514 0053, surplus property.

## NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:

<u>SECTION I</u> :	City Council hereby authorizes the transfer of property located at the former Salem Mall site, specifically Parcel No. H33 00514 0053, from the City of Trotwood to the TCIC and further authorizes the City Manager to take any and all steps necessary to transfer this property.
<u>SECTION II</u> :	City Council declares this property located at the former Salem Mall site, specifically Parcel No. H33 00514 0053, surplus property.
<u>SECTION III</u> :	It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that any and all deliberations of this Council that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including but not limited to, Section 121.22 of the Ohio

**SECTION IV:** This Ordinance shall take effect at the earliest time allowed by law.
